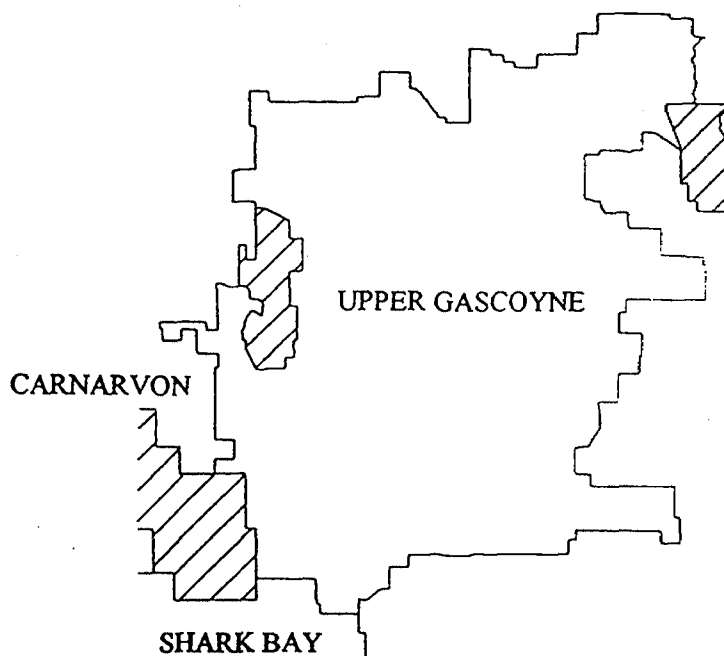

**SOIL AND LAND CONSERVATION ACT 1945****SOIL AND LAND CONSERVATION (KALANNIE LAND CONSERVATION DISTRICT)  
ORDER 1995**

Made by His Excellency the Governor in Executive Council under Section 22 and 23 of the *Soil and Land Conservation Act 1945* on the recommendation of the Minister for Primary Industry.

**Citation**

1. This order may be cited as the *Soil and Land Conservation Act (Kalannie Land Conservation District) Order 1995*.

**Interpretation**

2. In this order—

“appointed member” means a person appointed under clause 5 (1)(b) or (c) to be a member of the committee;

“commissioner” means the person for the time being holding or acting in the office of the Commissioner for Soil Conservation;

“committee” means the Land Conservation District Committee for the Kalannie Land Conservation District;

“member” means a member of the Committee;

“the district” means the Kalannie Land Conservation District constituted by clause 3;

“the producer organisations” means the bodies known respectively as the Western Australian Farmers Federation (Inc) and the Pastoralists and Graziers Association of Western Australia.

**Kalannie Land Conservation District**

3. The land described in the Schedule to this order is hereby constituted the Kalannie Land Conservation District.

**Establishment of the committee**

4. Pursuant to Section 23 (2) of the Soil and Land Conservation Act 1945 there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Kalannie Land Conservation District.

**Constitution of the committee**

5. (1) It is hereby determined on the recommendation of the Minister, after consultation with the Shire of Dalwallinu and the Shire of Koorda that the committee shall comprise 30 members of whom—

- (a) one shall be the Commissioner of Soil and Land Conservation or his nominee;
- (b) one shall be appointed by the Commissioner on the nomination of the Shire of Dalwallinu;
- (c) one shall be appointed by the Commissioner on the nomination of the Shire of Koorda;
- (d) three shall be representatives from the Western Australian Farmers Federation Inc;
- (e) 24 shall be persons actively engaged in, or affected by or associated with landuse in the district;

(2) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of this appointment and is eligible for reappointment.

(3) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.

(4) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.

(5) If an appointed member—

- (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
- (b) has his appointment terminated by the Minister, pursuant to subclause (4);
- (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice;
- (d) resigns his office by written notice addressed to the Minister, the office of that appointed member becomes vacant.

**Proceedings of the committee**

6. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.

(2) At any meeting of the committee—

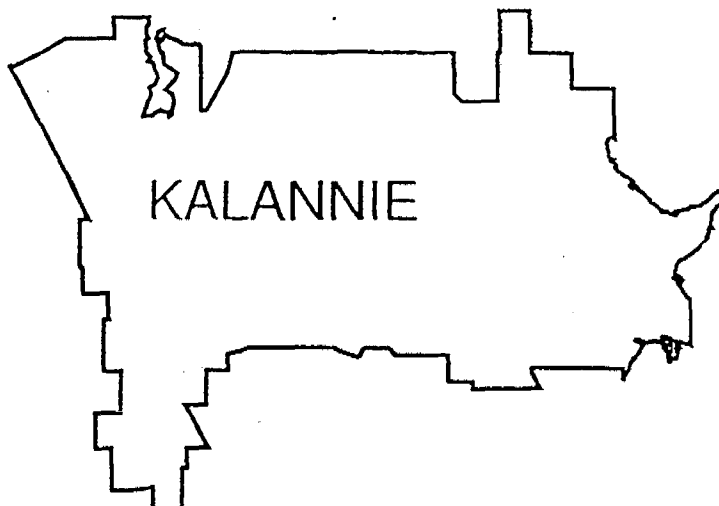
- (a) a majority of the members constitute a quorum;
- (b) the Chairperson will preside and where he or she is absent from the meeting the members may appoint one of their number to preside at that meeting;
- (c) each member present is entitled to a deliberative vote; and
- (d) where the votes cast on any question are equally divided the Chairperson, or the presiding member in terms of paragraph (b), shall have a casting vote.

(3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.

(4) To the extent that it is not prescribed, the committee may determine its own procedure.

## PART XI — PENALTIES AND PROCEEDINGS

## Penalties

340. (1) A person who, either by act or omission, contravenes Part VIII or Part IX of these regulations commits an offence.

Penalty: In the case of an individual, \$5 000; and  
In the case of a body corporate, \$20 000.

(2) A person who, either by act or omission, contravenes Part X of these regulations commits an offence.

Penalty: \$200.

1. This notice may be cited as the *Shark Bay Scallop Limited Entry Fishery Amendment Notice 1995*.

**Principal Notice**

2. In this notice the *Shark Bay Scallop Limited Entry Fishery Notice 1994 Notice No. 655\** is referred to as the principal notice.

**Clause 11 amended**

3. Clause 11 of the principal notice is amended by—

(a) deleting paragraphs (a) and (b) of subclause (1) and inserting the following paragraphs—

" (a) a class A boat other than by a maximum of two seven fathom nets and one try net;  
and

(b) a class B boat other than by a maximum of either two or three or four eight fathom nets as endorsed on the licence and one try net; "; and

(b) inserting after subclause (6) the following subclause—

" (7) A class A boat shall not use nets other than nets that have—

(a) the ground rope equal to or longer than the head rope;

(b) the head rope sweeps less than or equal to the ground rope sweeps;

(c) the head rope and ground rope sweeps equal to or longer than two metres; and

(d) drop chains that are equal to or further apart than one metre. ".

**Clause 15 amended**

4. Clause 15 of the principal notice is amended by deleting subclause (2) and substituting the following subclause—

" (2) Subject to subclause (3) all boats are exempted from the provisions of subclause (1) when trialling gear in the area of water described in Schedule 5 provided that—

(a) the codend is open when the gear is being trialled;

(b) no prawns or scallops are held on board the boat; and

(c) trials are only undertaken during the hours of daylight. ".
