Consumer Credit (Western Australia) Code Regulations Amendment Order 2008

Made by the Governor in Executive Council under section 6 of the Act.

1. Citation

This order is the *Consumer Credit (Western Australia) Code Regulations Amendment Order 2008*.

2. The regulations amended

The amendments in this order are to the *Consumer Credit (Western Australia) Code Regulations*.

3. Commencement

This order comes into operation as follows:

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

4. Section 3 amended

Section 3 is amended by inserting in the appropriate alphabetical position —

“

“**authorised deposit-taking institution**” has the meaning given in the *Banking Act 1959* (Commonwealth) section 5(1);

”.

5. Section 5B inserted

After section 5A the following section is inserted —

“

5B. Application of Code to provision of credit under bill facilities

The Code applies to the provision of credit arising out of a bill facility unless the credit is provided by an authorised deposit-taking institution.

”.

6. Section 6F amended

Section 6F(2) is repealed.

DOG ACT 1976
Shire of Cunderdin
DOGS LOCAL LAW 2008

Under the powers conferred by the *Dog Act 1976* and under all other powers enabling it, the Council of the Shire of Cunderdin resolved on 23 July 2008 to make the following local law.

The *Shire of Gnowangerup Dogs Local Law 2007* as published in the *Government Gazette* of 30 November 2007 is adopted as a local law of the Shire of Cunderdin with the modifications as set out below.

1. Preliminary

Wherever the words "Shire of Gnowangerup" is mentioned in the local law substitute with the words "Shire of Cunderdin".

2. Clause 1.1 amended

Clause 1.1 is deleted and substituted with—

“1.1 This local law may be cited as the *Shire of Cunderdin Dogs Local Law 2008*.”.

3. Clause 1.2 amended

Clause 1.2 is deleted and substituted with—

“ 1.2 Definitions

In this local law unless the context otherwise requires—

“Act” means the *Dog Act 1976*;

“authorized person” means a person authorized by the local government to perform all or any of the functions conferred on an authorized person under this local law;

“CEO” means the Chief Executive Officer of the local government;

“local government” means the Shire of Cunderdin;

“pound keeper” means a person authorized by the local government to perform all or any of the functions conferred on a “pound keeper” under this local law;

“Regulations” means the *Dog Regulations 1976*;

“thoroughfare” has the meaning given to it in section 1.4 of the *Local Government Act 1995*; and

“town planning scheme” means a town planning scheme made by the local government under the *Planning and Development Act 2005* which applies throughout the whole or a part of the district.”.

4. Clause 5.2 amended

In Clause 5.2(1), sub-paragraphs (a), (b) and (c) are deleted and substituted with—

“ (a) Reserve 23439 (Lot 366—Mitchell Street, Cunderdin); and

(b) Lot 418 Throssell Road, Meckering—(Old Meckering Townsite).”

CHICKEN MEAT INDUSTRY ACT 1977 SPECIFIED AMOUNT

It is hereby notified as required by section 16(6)(b) of the *Chicken Meat Industry Act 1977* that on the 25th July 2008, the Chicken Meat Industry Committee determined, pursuant to section 16(1) of the Act, that the average price that is to be paid by processors to growers for broiler chickens is—

- 70.66 cents per bird for all birds placed after 30 June 2008.

GENETICALLY MODIFIED CROPS FREE AREAS ACT 2003

GENETICALLY MODIFIED CROPS FREE AREAS EXEMPTION ORDER (NO. 2) 2008

Made by the Minister for Agriculture and Food under section 6 of the Act.

1. Citation

This is the *Genetically Modified Crops Free Areas Exemption Order (No. 2) 2008*.

2. Duration

This order comes into operation on the date of its publication and remains in force until 31 December 2009.

3. Exemption

The Crown is exempt from the application of section 5(1) of the Act in relation to the cultivation of genetically modified herbicide resistant canola to serve as a control in tests for the unintended presence of genetically modified herbicide resistant canola in non-genetically modified canola and for the development of tests for the same purpose.

4. Conditions

This exemption is subject to the following conditions—

- (a) The plants must be cultivated in trays in locked greenhouses at secure locations within the premises of the Department of Agriculture and Food at South Perth or Manjimup premises.
- (b) The plants must not be removed from the greenhouses except to enable them to be sprayed with herbicide and must be returned to the greenhouse immediately after spraying.
- (c) The plants are to be prevented from flowering and producing viable seed.
- (d) At the conclusion of the testing the plants and the soil in which the plants were cultivated are to be disposed of using the quarantine approved deep burial method.

GAS STANDARDS ACT 1972**PROHIBITION ORDER****Flexible Liquid Fuel Hoses for LPG Powered Mobile Engines**

Made by the Director of Energy Safety under section 13H of the Act.

The Director of Energy Safety hereby gives notice that pursuant to section 13H of the *Gas Standards Act 1972* he has formed the opinion that liquefied petroleum gas fuelled engine type gas installations (such as are commonly installed in motor vehicles) are likely to become unsafe in use if the fuel supply lines of the gas installations contain an unacceptable type and length of flexible hose for any of the following purposes—

- to connect the mobile engine's gas filling connection and gas storage tank; and
- to connect the mobile engine's gas fuel storage tank and vaporiser-regulator.

The types of hoses referred to above are those that leach 25 milligram or more of harmful plasticiser (such as phthalates and adipates) in total per installation and as a result are likely to cause unsafe operation of the engine's vaporiser and/or hose(s). Information on the characteristics of hoses tested by EnergySafety (or approved by EnergySafety) can be obtained from www.energysafety.wa.gov.au.

The total amount of leaching is a function of the type and length of hose installed. A type of hose which under test conditions leached 4 milligrams per metre of harmful plasticiser may be used for a total length of up to 6.25 metres per installation. Alternatively a type of hose which under test conditions leached 50 milligrams per metre of harmful plasticiser in the test may be used at the rate of 500 millimetres per installation.

Therefore, pursuant to section 13H of the Act, the Director hereby orders that as of 1 December 2008, no person may sell, hire, use or install flexible liquid fuel hoses for or in mobile vehicle gas installations or replace such hoses on existing installations as part of their repair or maintenance, if the hose installation of that vehicle gas installation is expected to leach, in total, in excess of 25 milligram of harmful plasticisers, based on the EnergySafety hose information cited above.

The Prohibition Order *Flexible Liquid Fuel Hoses For LPG Powered Mobile Engines* published in the *Government Gazette* (page 1915) on 16 May 2008 is hereby revoked.

ELECTRICITY CORPORATIONS ACT 2005**ELECTRICITY CORPORATIONS (TRANSACTIONS EXEMPT FROM MINISTERIAL APPROVAL)
ORDER 2008**

Made by the Minister for Energy under section 69(1) of the *Electricity Corporations Act 2005*.

1. Citation

This order is the *Electricity Corporations (Transactions Exempt from Ministerial Approval) Order 2008*.

2. Commencement

This order comes into operation on the date it is published in the *Government Gazette*.

3. Interpretation

In this order—

“**Coordinator**” means the Coordinator of Energy referred to in section 4 of the *Energy Coordination Act 1994*.

“**CPI number**” means—

- (a) the Consumer Price Index, All Groups index number, weighted average for 8 capital cities, calculated and published by the Australian Statistician; or
- (b) if there is no number described in paragraph (a), a corresponding index number calculated and published by a person appointed by the Coordinator.

“**threshold limit**” means the sum of \$50 million or, where applicable, such other sum calculated in accordance with clause 5 of this order.

4. Transactions exempt from Ministerial Approval

Subject to clause 6, the following class of transaction is exempt from the operation of section 68 of the *Electricity Corporations Act 2005*—

- (a) transactions entered into by the Electricity Retail Corporation for the supply of electricity and/or gas where the total value of the transaction, whether or not the transaction comprises one or more agreements or arrangements to effect the transaction, is less than or equal to the threshold limit.

5. Adjustment of threshold limit for 2009/10 financial year and thereafter

(1) This clause applies to the calculation of the threshold limit for transactions for the supply of electricity and/or gas in the 2009/10 financial year or a subsequent financial year (in this clause called “**the relevant year**”).

(2) If the CPI number for the quarter ending on the 31 March immediately before the beginning of the relevant year (“**CPI_r**”) is more than the CPI number for the quarter ending on the 31 March that was a year earlier (“**CPI_{r-1}**”), the threshold limit to be used for the relevant year is—

$$R_n = R_{n-1} \times \left(\frac{CPI_r}{CPI_{r-1}} \right)$$

where—

R_n is the threshold limit for the relevant year;

R_{n-1} is threshold limit that applied immediately before the relevant year began.

(3) If CPI_r is not more than CPI_{r-1} , the threshold limit to be used for the relevant year is the threshold limit that applied immediately before the relevant year began.
