NOTICE 1998**

FD 58/98

Made by the Minister for Fisheries under section 10B of the Act.

**Citation**

1. This notice may be cited as the *South Coast Herring Fishery Voluntary Fisheries Adjustment Scheme Notice 1998*.

**Interpretation**

2. In this notice—

“authorization” means a fishing boat licence which permits the holder to use a boat to take herring by herring trap net from a specified beach on the south coast of Western Australia east of Cape Beaufort;

“committee” means the “Voluntary Resource Reallocation and Buyout Committee” established on 25 June 1997 under s.11 of the Act;

“fishing boat licence” means a fishing boat licence as defined in the *Fish Resources Management Regulations 1995*;

“South Coast Herring Fishery” means the fishery comprised of those persons who hold a fishing boat licence that is endorsed to authorise the holder to fish for herring by herring trap net from a specified beach east of Cape Beaufort on the south coast of Western Australia;

“scheme” means the South Coast Herring Fishery Voluntary Fisheries Adjustment Scheme established in clause 3.

**Establishment of fisheries adjustment scheme**

3. There is established a fisheries adjustment scheme in respect of the South Coast Herring Fishery to be known as the *South Coast Herring Fishery Voluntary Fisheries Adjustment Scheme*.

**Objective**

4. The objective of the scheme is to reduce the number of boats that may be used to commercially fish in the South Coast Herring Fishery by reducing the number of fishing boat licences that permit the holder to use a boat to commercially fish in that fishery.

**The fishery to which this scheme applies**

5. The fishery to which this scheme applies is the South Coast Herring Fishery.

**Who may offer to surrender an authorization**

6. Any person who is the holder of an authorization is entitled to offer the surrender of the authorization.

**Manner of operation**

7. The manner of operation of the scheme shall be—

(a) invitations for offers to surrender authorizations shall be made in accordance with section 10C(4) of the Act;

(b) any offer shall be submitted to the committee in the form approved by the committee;

(c) the committee shall forward any offers to the Minister and advise the Minister whether to accept or decline any offer or to make a counter offer;

(d) the Minister shall respond to any offer in accordance with section 10(5) of the Act after considering any advice of the committee.

**Duration of scheme**

8. This scheme shall operate from 1 February 1998 to 30 June 2000.

**Terms of the scheme**

9. The terms of the scheme are that—

(a) provided that the objective specified in clause 4 will be attained, compensation in an amount agreed between the Minister and the holder of an authorization shall be paid for the surrender of an authorization; and

(b) a person who surrenders an authorization as described in (a) shall retain any proprietary rights in the fishing boat and fishing gear to which the authorization relates.

**Citation**

1. These by-laws may be cited as the *By-law 66 Amendment 1997*.

**Commencement**

2. These by-laws come into operation on the latter of the day on which they are published in the *Gazette* and the day on which the *Equal Opportunity Amendment Act 1997* comes into operation.
