**LOCAL GOVERNMENT ACT 1995***Shire of Murray***CONSOLIDATED AMENDMENT LOCAL LAW 2018**

Under the powers conferred on it by the *Local Government Act 1995* and under all other enabling powers, the Council of Shire of Murray resolved on 22 March 2018 to make the following local law.

**1. Citation**

This local law may be cited as the *Shire of Murray Consolidated Amendment Local Law 2018*.

**2. Commencement**

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

**3. Principal Local Law**

In this local law the *Shire of Murray Consolidated Local Laws* as published in the *Government Gazette* (No. 250) on 30 December 1999 is referred to as the Principal Local Law.

**4. Principal Local Law amended**

4.1 The Principal Local Law is amended as described in clauses 4.2 to 4.5 of this local law.

4.2 In clause 2.1.1 of the Principal Local Law insert the following definition after the definition of “Minister” and before the definition of “nuisance”—

“**model aircraft**” means unmanned mechanically operated aircraft capable of flight, whether operated by remote control or otherwise and includes helicopters, blimps, rockets, drones and remotely piloted aircraft;

4.3 In clause 3.4 of the Principal Local Law delete clause (y).

4.4 In clause 3.5 of the Principal Local Law consecutively amended the existing clauses, as follows—

- (a) (i) becomes (j); and,
- (b) (j) becomes (k).

4.5 In clause 3.5 of the Principal Local Law immediately after clause (h) insert the following clause—

- (i) fly any model aircraft;

### CONSERVATION AND LAND MANAGEMENT ACT 1984

#### NGARI CAPES MARINE PARK (CLASSIFIED WATERS) NOTICE 2018

Made by the Minister for Environment under section 62(1a) of the Act.

#### 1. Citation

This is the *Ngari Capes Marine Park (Classified Waters) Notice 2018*.

#### 2. Interpretation

(1) In this notice—

**approved management plan** means the management plan for the Ngari Capes Marine Park, set out in the *Ngari Capes Marine Park Management Plan 74 2013-2023*, approved by the Minister under sections 14 and 60 of the Act as notified in the *Gazette* of 5 February 2013, and as amended in the *Gazette* of 23 September 2016, and the *Gazette* of 2 March 2018;

**coastal waters of the State** has the meaning given to that term in the *Coastal Waters (State Powers) Act 1980* (Commonwealth) section 3(1);

**high water mark** means the ordinary (mean of) high water mark at spring tides as defined in the *Land Administration Act 1997* section 3(1);

**low water mark** means the ordinary (mean of) low water mark at spring tides;

**Ngari Capes Marine Park** means the part of Western Australian waters reserved as Ngari Capes Marine Park under section 13 of the Act and classified as Class A by the *Ngari Capes Marine Park Order 2012*, published in the *Gazette* of 12 June 2012;

**Table 7** means *Table 7 Permitted commercial uses in the Ngari Capes Marine Park*, set out in the approved management plan;

**Table 8** means *Table 8 Permitted recreational uses in the Ngari Capes Marine Park*, set out in the approved management plan;

**Western Australian waters** has the meaning given to that term in section 13(8) of the Act.

(2) All geographic coordinates are expressed in terms of the World Geodetic System 1984 (WGS84).

#### 3. Classification of recreation areas

All waters of the Ngari Capes Marine Park described in Schedule 2 are classified under section 62(1a)(a) of the Act as recreation areas.

#### 4. Classification of general use areas

All waters of the Ngari Capes Marine Park described in Schedule 4 are classified under section 62(1a)(b) of the Act as general use areas.

#### 5. Classification of sanctuary areas

All waters of the Ngari Capes Marine Park described in Schedule 1 are classified under section 62(1a)(c) of the Act as sanctuary areas.

#### 6. Classification of special purpose areas

All waters of the Ngari Capes Marine Park described in Schedule 3 are classified under section 62(1a)(d) of the Act as special purpose areas.

#### 7. Declaration of certain types of recreational fishing as incompatible with another specified recreational purpose in recreation areas

Under section 13B(3A)(b) of the Act, recreational fishing of the type described in Table 8 as recreational specimen shell collecting (alive), recreational coral and live rock collecting, and charter vessels—fishing are declared to be incompatible with the recreational purpose of—

- (a) providing a family oriented recreation beach for the area classified as recreation area under clause 3 and described in Schedule 2 item 1 Cowaramup Bay Recreation Zone; and
- (b) providing for an ongoing high quality recreation experience at a known tourism node for the area classified as recreation area under clause 3 and described in Schedule 2 item 2 Hamelin Bay Recreation Zone.

**8. Declaration of certain types of recreational fishing as incompatible with another specified recreational purpose in certain recreation areas**

Under section 13B(3A)(b) of the Act, recreational fishing of the types described in Table 8 as recreational crabbing (with the exception of blue manna crabs), recreational specimen shell collecting (dead), recreational octopus fishing using pots/traps and recreational octopus fishing other than by pot/trap are declared to be incompatible with the recreational purpose of providing a family oriented recreation beach for the area classified as recreation area under clause 3 and described in Schedule 2 item 1 Cowaramup Bay Recreation Zone.

**9. Declaration of aquaculture as incompatible with a specified conservation purpose in special purpose areas**

Under section 13B(3B)(a) of the Act, aquaculture is declared to be incompatible with the conservation purpose of—

- (a) providing protection to nearshore and offshore habitats for all the areas classified as special purpose areas (surfing) under clause 6 and described in Schedule 3 items 1-10 Windmills Special Purpose Zone (surfing), Three Bears Special Purpose Zone (surfing) Yallingup Special Purpose Zone (surfing), Moses Rock Special Purpose Zone (surfing), Goannas Special Purpose Zone (surfing), Moses Beach Special Purpose Zone (surfing), Gallows/Guillotine Special Purpose Zone (surfing), Lefthanders Special Purpose Zone (surfing), Margaret River Special Purpose Zone (surfing), Redgate Special Purpose Zone (surfing); and
- (b) providing protection to nearshore habitats and communities for all the areas classified as special purpose areas (shore-based activities) under clause 6 and described in Schedule 3 items 11-12 Eagle Bay Special Purpose Zone (shore-based activities) and Cosy Corner Special Purpose Zone (shore-based activities).

**10. Declaration of certain types of commercial fishing as incompatible with a specified conservation purpose in special purpose areas**

Under section 13B(3B)(c) of the Act, commercial fishing of the types described in Table 7 as commercial rock lobster fishing, commercial trawl fishing, commercial coral, 'live rock' and 'live sand' collecting, and commercial octopus fishing are declared to be incompatible with the conservation purpose of—

- (a) providing protection to nearshore and offshore habitats for all the areas classified as special purpose areas (surfing) under clause 6 and described in Schedule 3 items 1-10 Windmills Special Purpose Zone (surfing), Three Bears Special Purpose Zone (surfing) Yallingup Special Purpose Zone (surfing), Moses Rock Special Purpose Zone (surfing), Goannas Special Purpose Zone (surfing), Moses Beach Special Purpose Zone (surfing), Gallows/Guillotine Special Purpose Zone (surfing), Lefthanders Special Purpose Zone (surfing), Margaret River Special Purpose Zone (surfing), Redgate Special Purpose Zone (surfing); and
- (b) providing protection to nearshore habitats and communities for all the areas classified as special purpose areas (shore-based activities) under clause 6 and described in Schedule 3 items 11-12 Eagle Bay Special Purpose Zone (shore-based activities) and Cosy Corner Special Purpose Zone (shore-based activities).

**11. Declaration of certain types of commercial fishing as incompatible with a specified conservation purpose in certain special purpose areas**

Under section 13B(3B)(c) of the Act, commercial fishing of the types described in Table 7 as commercial salmon fishing, commercial demersal gillnet/ longline fishing, commercial wetline fishing, commercial beach seine fishing, commercial purse seine fishing, boat based commercial abalone fishing, boat based commercial aquarium fishing and boat based commercial specimen shell collecting are declared to be incompatible with the conservation purpose of providing protection to nearshore habitats and communities for all the areas classified as special purpose areas (shore-based activities) under clause 6 and described in Schedule 3 items 11-12 Eagle Bay Special Purpose Zone (shore-based activities) and Cosy Corner Special Purpose Zone (shore-based activities).

**12. Declaration of certain types of recreational fishing as incompatible with a specified conservation purpose in certain special purpose areas**

Under section 13B(3B)(e) of the Act, recreational fishing of the types described in Table 8 as recreational specimen shell collecting (alive), recreational coral and live rock collecting, and recreational octopus fishing using pots/traps are declared to be incompatible with the conservation purpose of—

- (a) providing protection to nearshore and offshore habitats for all the areas classified as special purpose areas (surfing) under clause 6 and described in Schedule 3 items 1-10 Windmills Special Purpose Zone (surfing), Three Bears Special Purpose Zone (surfing) Yallingup Special Purpose Zone (surfing), Moses Rock Special Purpose Zone (surfing), Goannas Special Purpose Zone (surfing), Moses Beach Special Purpose Zone (surfing), Gallows/Guillotine Special Purpose Zone (surfing), Lefthanders Special Purpose Zone (surfing), Margaret River Special Purpose Zone (surfing), Redgate Special Purpose Zone (surfing); and
- (b) providing protection to nearshore habitats and communities for all the areas classified as special purpose areas (shore-based activities) under clause 6 and described in Schedule 3 items 11-12 Eagle Bay Special Purpose Zone (shore-based activities) and Cosy Corner Special Purpose Zone (shore-based activities).

### 13. Declaration of certain types of recreational fishing as incompatible with a specified conservation purpose in certain special purpose areas

Under section 13B(3B)(e) of the Act, recreational fishing of the type described in Table 8 as recreational rock lobster fishing by pot is declared to be incompatible with the conservation purpose of providing protection to nearshore and offshore habitats for the areas classified as special purpose area (surfing) under clause 6 and described in Schedule 3 items 1-8 and item 10 Windmills Special Purpose Zone (surfing), Three Bears Special Purpose Zone (surfing) Yallingup Special Purpose Zone (surfing), Moses Rock Special Purpose Zone (surfing), Goannas Special Purpose Zone (surfing), Moses Beach Special Purpose Zone (surfing), Gallows/Guillotine Special Purpose Zone (surfing), Lefthanders Special Purpose Zone (surfing), Redgate Special Purpose Zone (surfing).

### 14. Declaration of certain types of recreational fishing as incompatible with a specified conservation purpose in certain special purpose areas

Under section 13B(3B)(e) of the Act, recreational fishing of the types described in Table 8 as spearfishing, charter vessels—fishing, boat based recreational abalone fishing, boat based recreational line fishing, boat based recreational netting, boat based recreational crabbing, boat based recreational specimen shell collecting—dead, boat based recreational rock lobster fishing by pot or hand and boat based recreational octopus fishing other than by pot/trap are declared to be incompatible with the conservation purpose of providing protection to nearshore habitats and communities for all the areas classified as special purpose area (shore-based activities) under clause 6 and described in Schedule 3 items 11-12 Eagle Bay Special Purpose Zone (shore-based activities) and Cosy Corner Special Purpose Zone (shore-based activities).

### 15. Declaration of exploratory drilling for, or production of, petroleum, geothermal energy resources or geothermal energy as incompatible with a specified conservation purposes in certain special purpose areas

Under section 13B(3B)(g) of the Act, activities described in Table 8 as mineral and petroleum exploration, and mineral and petroleum development are declared to be incompatible with the conservation purpose of providing protection to nearshore habitats and communities for all the areas classified as special purpose areas (shore-based activities) under clause 6 and described in Schedule 3 items 11-12 Eagle Bay Special Purpose Zone (shore-based activities) and Cosy Corner Special Purpose Zone (shore-based activities).

## Schedule 1—Sanctuary Areas

### 1. East Geographe Bay Sanctuary Zone

All that portion of Ngari Capes Marine Park contained within and bounded by a line—

- (i) commencing offshore in Geographe Bay generally north-north-west of the mouth of Wonnerup Inlet at the point located at the intersection of the seaward limit of the coastal waters of the State and the north-westerly prolongation of the geodesic joining the co-ordinates at Latitude 33°32'45" South, Longitude 115°24'36" East offshore and Latitude 33°34'54" South, Longitude 115°27'15" East on the mainland, and from that point;
- (ii) extending south-easterly along that prolongation and further continuing along that geodesic to the point located at the intersection of that geodesic and the mainland low water mark;
- (iii) thence generally south-westerly along that water mark to the point located at the intersection of that water mark and the geodesic joining the co-ordinates at Latitude 33°35'38.40" South, Longitude 115°26'34.20" East on the mainland and Latitude 33°35'30.60" South, Longitude 115°26'23.40" East offshore;
