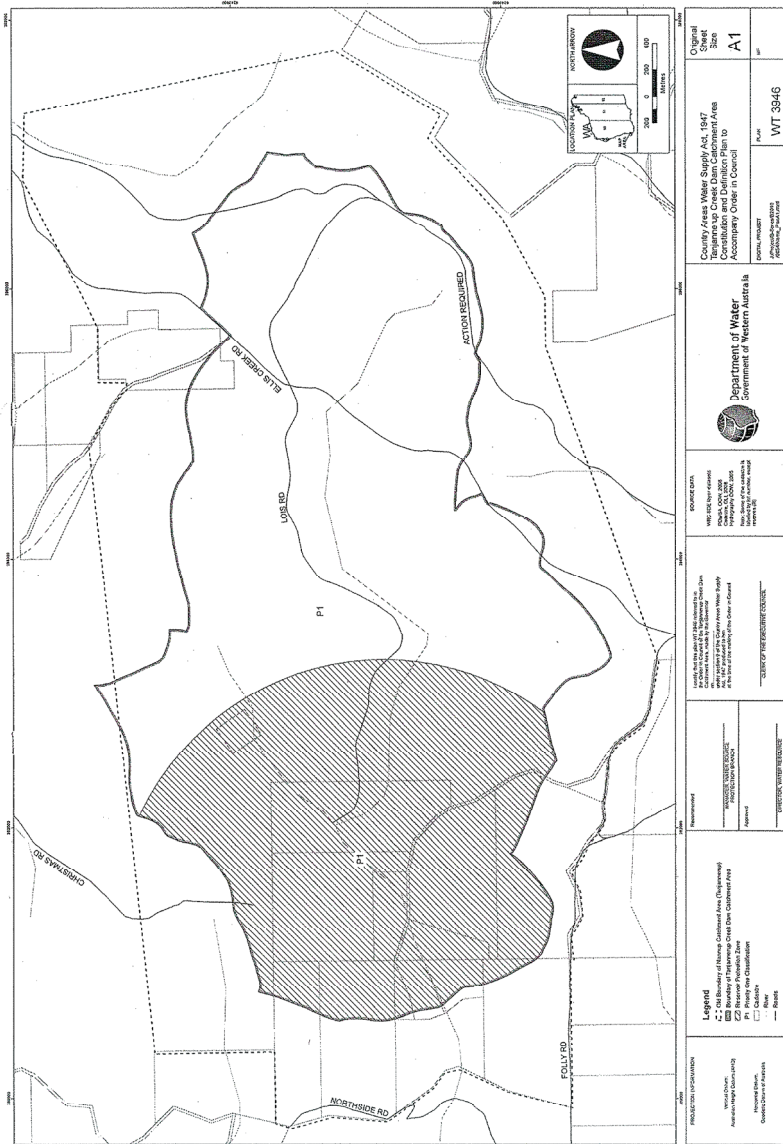

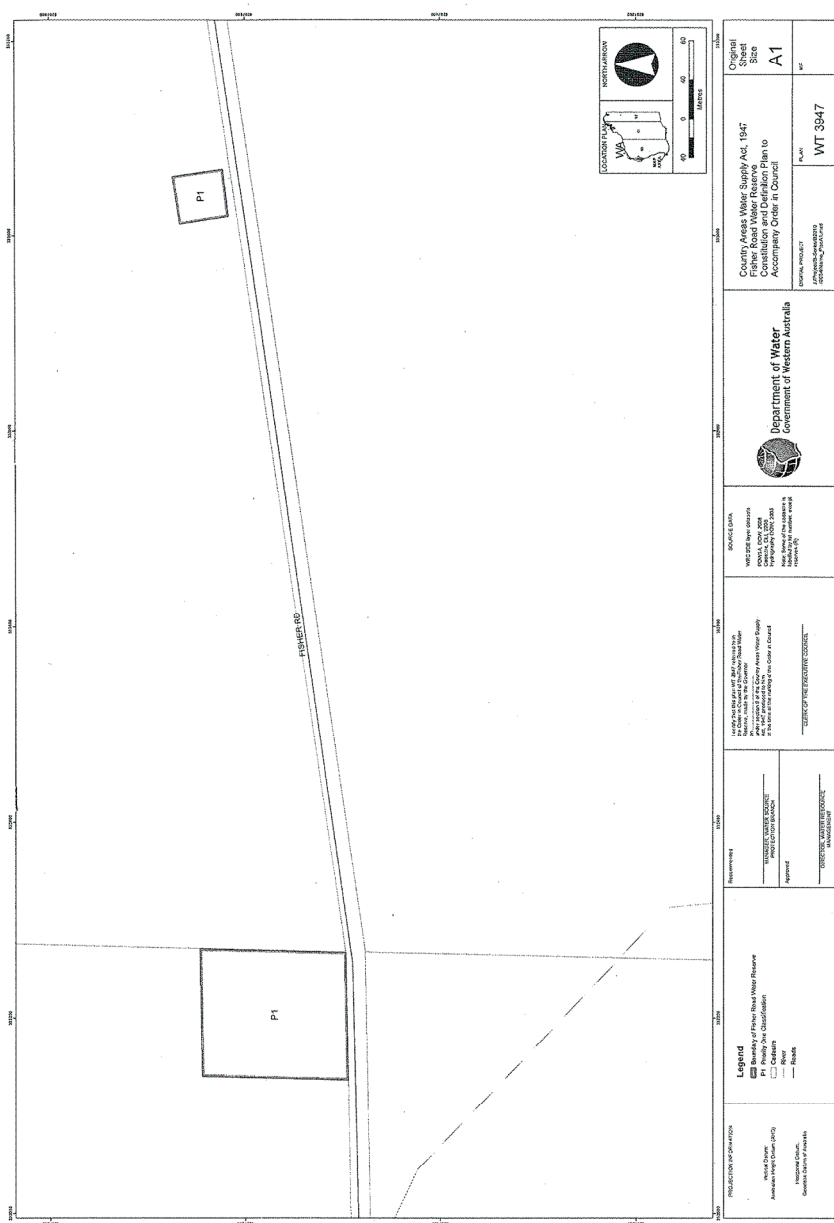

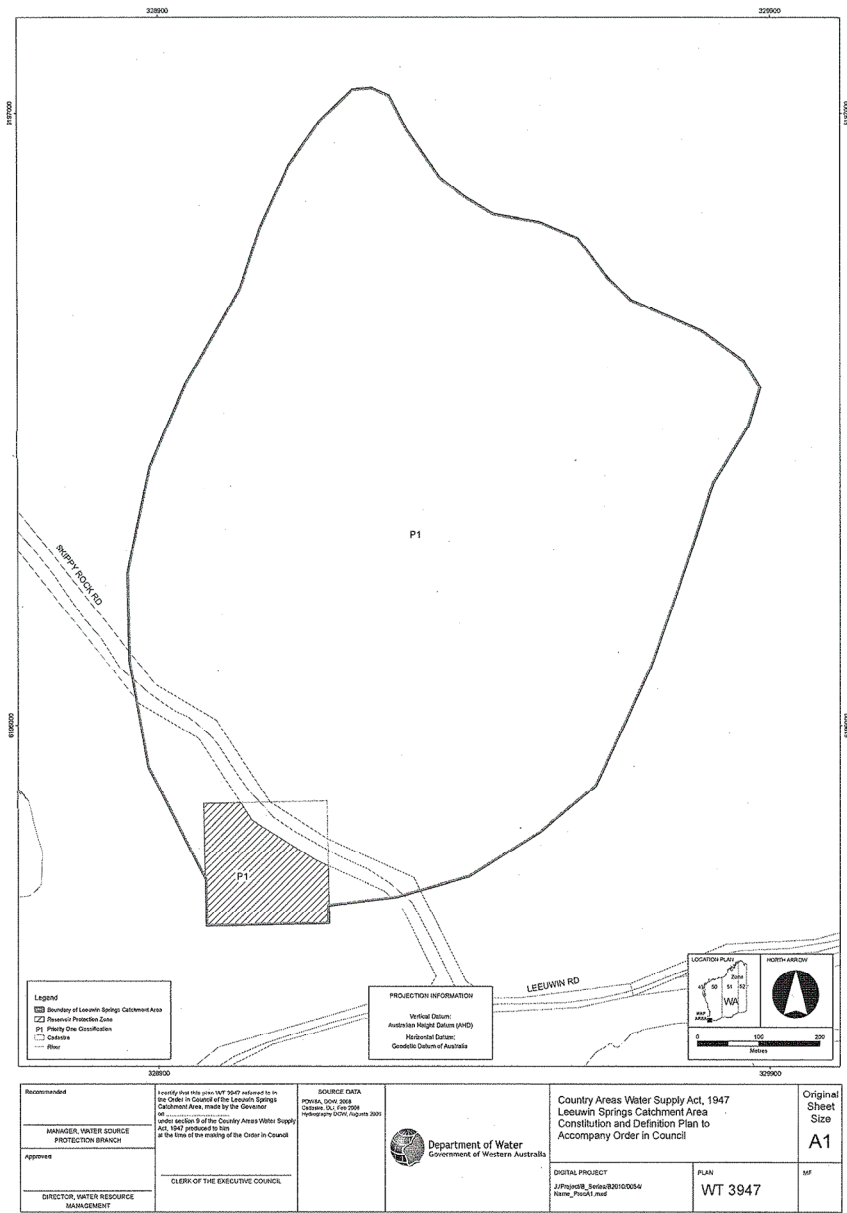

#### ELECTORAL ACT 1907

##### REGISTRATION OF POLITICAL PARTIES

##### Proposal to Cancel Registration

##### Nurses for Health

Under section 62L(2)(c) of the *Electoral Act 1907* the Electoral Commissioner may cancel the registration of a political party if the Electoral Commissioner is satisfied on reasonable grounds that the candidates at a conjoint election held after the registration of the party did not include at least one candidate endorsed by the party.

The Electoral Commissioner is satisfied on reasonable grounds that the candidates at a conjoint election held after the registration of Nurses for Health did not include at least one candidate endorsed by Nurses for Health.

It is therefore proposed to cancel the registration of Nurses for Health as a political party in Western Australia.

This action requires the Electoral Commissioner to—

- (a) give written notice of the proposed cancellation to the secretary of the party at the address shown in the register;
- (b) give notice of the proposed cancellation in—
  - (i) the *Gazette* (this notice); and
  - (ii) a newspaper circulating generally in the State;

Notice in accordance with (a) has been given and this gazettal is in accordance with (b)(i) above. A similar notice will appear in *The West Australian* on 7 March 2009.

Persons may, by 20 March 2009, object to the Electoral Commissioner in writing against the proposed cancellation.

## Clause 10 closures of areas within the Fishery

I, Stuart Smith, Chief Executive Officer of the Department of Fisheries Western Australia, in accordance with the *Shark Bay Prawn Management Plan 1993*, hereby give notice that I have cancelled *Determination No. 2 of 2008* which set out the dates, times and areas that fishing is prohibited in the Shark Bay Prawn Managed Fishery.

I hereby give notice that a new determination (*Determination No. 1 of 2009*) has been made in accordance with clause 10 of the *Shark Bay Prawn Management Plan 1993*, which sets out the dates, times and areas that fishing is prohibited in the Shark Bay Prawn Managed Fishery during the period commencing from the date of gazettal of this notice and ending on 1 June 2010.

A copy of this determination which is signed by me may be obtained from, or inspected at the Head Office of the Department of Fisheries located at 168 St Georges Terrace Perth or the offices of the Department of Fisheries located at 83 Olivia Terrace, Carnarvon and Knight Terrace, Denham.

## Determination of Areas Closed to Fishing for Prawns

## Determination No. 1 of 2009

I, Stuart Smith, Chief Executive Officer of the Department of Fisheries Western Australia, in accordance with clause 10 of the *Shark Bay Prawn Management Plan 1993*, do hereby—

1. Cancel *Determination No.2 of 2008* dated 31 July 2008.
2. Prohibit fishing for prawns in those parts of the Shark Bay Prawn Managed Fishery (the Fishery), between the times and dates provided for in items (a) to (f) below—
  - (a) Fishing for prawns is prohibited in all parts of the Fishery from the date of the gazettal of the Notice advising that I have made *Determination No. 1 of 2009*, to 1800 hours on 16 March 2009, except between 0800 and 1600 hours each day in that part of the Fishery bounded by a line commencing at the intersection of 24°50.00' south latitude and 113°21.50' east longitude and extending south along the meridian to the intersection of 24°52.75' south latitude and 113°21.50' east longitude; thence east along the parallel to the intersection of 24°52.75' south latitude and 113°23.50' east longitude; thence north along the meridian to the intersection of 24°50.00' south latitude and 113°23.50' east longitude; thence west along the parallel to the commencement point—**commonly known as the gear trial area**.
  - (b) Fishing for prawns is prohibited from 16 March 2009 to 29 October 2009—
    - (i) in all nursery areas described in Item 2 of the Schedule of the *Shark Bay Prawn Management Plan 1993*;
    - (ii) in that part of the Fishery south of a line commencing at the intersection of 25°40.59' south latitude and 113°02.87' east longitude (high water mark on Dirk Hartog Island); thence extending east along the parallel to the intersection of 25°40.59' south latitude and 113°04.80' east longitude; thence south easterly along the geodesic to the intersection of 25°41.00' south latitude and 113°05.63' east longitude; thence extending east along the parallel to the intersection of 25°41.00' south latitude and 113°08.00' east longitude; thence south easterly along the geodesic to the intersection of 25°46.00' south latitude and 113°13.00' east longitude; thence east along the parallel to the intersection of 25°46.00' south latitude and 113°19.00' east longitude; thence north along the meridian to the intersection of 25°38.00' south latitude and 113°19.00' east longitude; thence north westerly along the geodesic to the intersection of 25°32.00' south latitude and 113°25.00' east longitude; thence east along the parallel to the intersection of 25°32.00' south latitude and 113°29.74' east longitude (high water mark on Peron Peninsula)—**commonly known as the “Snapper/Trawl Closure”**, and;
    - (iii) in that part of the Fishery bounded by a line commencing at the intersection of 25°36.00' south latitude and 113°01.63' east longitude (high water mark on Dirk



Hartog Island); thence extending east along the parallel to the intersection of 25°36.00' south latitude and 113°03.75' east longitude; thence due south along the meridian to the intersection of 25°38.00' south latitude and 113°03.75' east longitude; thence west along the parallel to the intersection of 25°38.00' south latitude and 113°02.30' east longitude (high water mark on Dirk Hartog Island)—**commonly known as the “Withnell Point Closure”**.

- (c) Fishing for prawns is prohibited from 0800 hours on 3 August 2009 to 0800 hours on 29 October 2009 in that part of the Fishery bounded by a line commencing at the intersection of 25°26.00' south latitude and 113°55.50' east longitude (high water mark on the coastline of Western Australia); thence extending west along the parallel to the intersection of 25°26.00' south latitude and 113°40.00' east longitude; thence north westerly along the geodesic to the intersection of 25°20.40' south latitude and 113°30.60' east longitude; thence north along the meridian to the intersection of 25°15.20' south latitude and 113°30.60' east longitude; thence east along the parallel to the intersection of 25°15.20' south latitude and 113°50.83' east longitude (high water mark on the coastline of Western Australia); thence generally southerly along the high water mark of the coastline to the commencement point—**commonly known as the “Extended Nursery Area”**.
- (d) Fishing for prawns is prohibited between 0900 hours and 1800 hours each day between 17 March 2009 and 29 March 2009 and then between 0800 hours and 1700 hours each day from 30 March 2009 to 29 October 2009 in all parts of the Fishery south of 24°45.30' south latitude (**commonly known as that area south of Koks Island**).
- (e) Fishing for prawns is prohibited between 1100 hours and 1800 hours each day between 17 March 2009 and 29 March 2009 and then between 1000 hours and 1700 hours each day from 30 March 2009 to 29 October 2009 (with the exception of 29 October 2009 when fishing is prohibited after 0800 hours) in that part of the Fishery north of 24°45.30' south latitude (**commonly known as that area north of Koks Island**).
- (f) Fishing for prawns is prohibited in all parts of the Fishery from 0800 hours on 29 October 2009 to 0800 hours on 1 June 2010.

1. The Scheme (“Scheme”) under the *Charitable Trusts Act 1962* annexed to this Order be approved.
2. The Plaintiff’s and the Defendant’s reasonable costs and expenses of and incidental to preparing and advertising the Scheme and obtaining approval of the Scheme be paid out of, and be on a charge on, the trust property, being the land comprised in Certificate of Title Volume 1399 Folio 111, situated at 31 Hopetoun Terrace, Shenton Park in the State of Western Australia.

**CHARITABLE TRUSTS ACT 1962****SCHEME**

The following scheme be substituted for the scheme that was approved by the Honourable Justice Kennedy of the Supreme Court of Western Australia on the 7th May 1982 pursuant to the *Charitable Trusts Act 1962*.

1. The trustee of the trust, The Church Missionary Society—Western Australia Incorporated (formerly known as Western Australian Association of the Church Missionary Society of Australia) (“the Society”) shall sell the property situate at 31 Hopetoun Terrace, Shenton Park in the State of Western Australia, being the land comprised in Certificate of Title Volume 1399 Folio 111 (“the Shenton Park property”) as soon as practicable.
2. After payment of all the costs and expenses of the sale and of this Scheme, the Society shall hold the balance of the proceeds of the sale of the Shenton Park property upon trust to apply the income and capital to—
  - (a) the purchase of a residential property in the State of Western Australia (“Residential Property”) that complies or substantially complies with the requirements for rectories of the Diocese of Perth of the Anglican Church of Australia; and
  - (b) the promotion of the missionary work of the Society among Anglican congregations and other Christians in Western Australia.
3. Subject to clause (4), the Residential Property is to be used as a place of residence for one or more members of the staff of the Society who are engaged in the missionary work of the Society;
4. During any period when the Residential Property is not required for housing a member of the staff of the Society, it may be leased and the rents] income be applied to—
  - (a) the payment of a housing allowance to any member of the staff of the Society who is engaged in the missionary work of the Society and resides in the State of Western Australia; and
  - (b) the purposes referred to in clause (2)(b);
5. Should the Residential Property at any time cease to be suitable for housing a member of the staff of the Society, the Society may sell the Residential Property and after payment of the costs and expenses of sale, hold the balance of the proceeds of sale upon the trusts referred to in clause (2).
6. All other property and funds that are held by the Society pursuant to the terms of the Scheme approved by the Supreme Court on 7 May 1982 shall be held upon the trusts referred to in paragraph (2).
7. The Society’s and the Attorney General’s reasonable costs and expenses of and incidental to—
  - (a) preparing and advertising this Scheme; and
  - (b) obtaining approval of this Scheme;
 shall be paid out of, and be a charge on, the trust property.
