**DECISION IN THE MATTER OF THE APPLICATION FOR DECLARATION BY SPECIALIZED
CONTAINER TRANSPORT**

In accordance with section 44H of the *Trade Practices Act 1974*, I have decided not to declare the Kalgoorlie-Perth railway which is the subject of Specialized Container Transport's application for declaration under section 44F of the *Trade Practices Act*.

I have decided not to declare the service because Specialized Container Transport's application does not meet all the criteria required under section 44H(4) of the *Trade Practices Act*. Specifically, I am not satisfied that the application meets the criterion specified under section 44H(4)(e) regarding the existence of an effective State-based access regime.

The Government is committed to encouraging access to this important rail link. Currently four interstate rail operators have access to the Kalgoorlie-Perth rail service, including Specialized Container Transport.

The State already has in place an access regime for the interstate railway, which includes an arbitration mechanism to resolve disputes arising between Westrail, as the facility owner, and persons requiring access to the track. Westrail is required to operate in accordance with this regime under direction from the Minister for Transport. I have examined the regime in accordance with Section 44H(5) of the *Trade Practices Act* and I have decided that it is an effective access regime. The State is progressing, with high priority, legislation that will support and extend this regime. I intend to ask the National Competition Council early in 1998 to recommend that the Commonwealth Minister decide that the regime is an effective access regime under Section 44M of the *Trade Practices Act*.
